#### TERMS AND CONDITIONS FOR BECOMING A MEMBER OF INDIAN CANCER SOCIETY

- Granting of membership of the Indian Cancer Society is at the sole discretion of its National Managing Committee.
- The membership of the Indian Cancer Society is of two main categories -
- A) Individual Ordinary Members Non Voting
- B) Individual Ordinary Members Voting
- The annual Membership fees for Non Voting members is Rs 1,000/- plus 18% GST which is Rs 180/- Total Amount payable would be Rs. 1,180/-.
  The Membership fees could also be paid for 3 (Three) years at one go which would amount to Rs. 3,000/- plus 18% GST which is Rs. 540/-. Total Amount payable would be Rs. 3,540/-.
  These fees will be non-refundable.
- The annual Membership fees for Voting members is Rs 5,000/- plus 18% GST which is Rs 900/-Total Amount payable would be Rs. 5,900/-. The Membership fees could also be paid for 3 (three) years at one go which would amount to Rs. 15,000/- plus 18% GST which is Rs. 2,700/-. Total Amount payable would be Rs. 17, 700/. These fees will be non-refundable.
- All subscriptions shall be payable in advance on the first day of April in every year except that the first subscription of a person admitted to membership shall be payable on his application for membership.
- Any advance fees paid as a non-voting member will be adjusted against fees payable as voting member.
- The society shall email the soft copy of the Annual Report, Newsletters and other publications to the non voting members from time to time.
- The society shall email the soft copy of the Annual Report, Newsletters, other publications and Notice of the Annual General Meeting of the Society to the voting members from time to time.
- The Voting member will be expected to contribute tangibly to the activities and programs of the Society.
